I agree that I will not sell, give away or otherwise dispose of said animal to any person(s), dealer, retailer, auction, institute or any other entity for any reason. If at a later date I am unable or unwilling to keep adopted pet, Biggie Paws Rescue reserves first rights to reclaim the dog with a written explanation pending Board approval. Any dog returned over the age of 6 months must have a behavioral evaluation. I agree to pay a \$125 non refundable fee for a trainer's assessment chosen by a Biggie Paws Representative to see if dog is deemed adoptable. I also agree to hold the said dog until a foster or adopter is found.

I hereby agree to care for the above described pet in a humane and responsible manner and to provide it with clean and adequate shelter, food, water and veterinary care. I further agree that said pet shall reside inside my home and shall not be allowed to roam freely. I hereby agree to the adoption fee of \$_____ and I understand it is not refundable after a trial period of 14 days. I understand that if said dog is returned within that 14 day period I will receive a full refund minus a \$75 admin fee. I hereby understand and agree that Biggie Paws Rescue makes no representations or warranties, expressed or implied, about the above mentioned animal's temperament and is hereby absolved from any liability for future damages or injuries caused by said animal. I also understand and agree that Biggie Paws Rescue further gives no guarantees, expressed or implied, of the suitability of the animal to the adopter and/or his family.

Biggie Paws Rescue Inc. reserves the right to perform unannounced wellness checks and follow up visits to ensure the adopter is adhering to all guidelines agreed upon in all of the documents related to the adoption of a Biggie Paws Rescue dog. This is done to ensure proper care is being given to the adopted dog and if any mistreatment, neglect or improper care is found, we reserve the right to reclaim said dog.

I certify that all statements made by me on this adoption agreement are true and correct. I agree that Biggie Paws Rescue has the right to confiscate the above described dog in the event that any statements made by me are found to be false.
